Annual Enrollment / Benefits Fair 2015

Mark your calendar! 2016 Annual Enrollment is here! It runs **October 5 to October 30, 2015**. This is the only time you can make changes to certain benefits without having an eligible family event or qualifying employment change.

The annual [UW-Madison Employee Benefits and Resource Fair](#) will be held

Tuesday October 6 from 9:00 A.M to 3:00 PM at Union South—Varsity Hall. This is your opportunity to meet with staff from the health plans and other benefit vendors.

There will be many **important changes** to the State Group Health Insurance plans for 2016. These changes may result in higher

out-of-pocket expenses for medical care so it is important for everyone to be informed of the various changes and employee options. For example, all health insurance plans will have deductibles, cost-sharing and copays; and uniform dental benefits will change. The employer contribution to the health savings account for the high-deductible health plans will also change.
